1. HLC Update – Ms. Halley and Mr. Boice
 - ◆ An update was given and the draft schedule was provided for the Higher Learning Commission campus visit on February 9-12.
2. Spring Enrollment and Ongoing Coordination of Actions – Ms. Halley, Mr. Hughes, Mr. Becker, Mr. Ware, Dr. Tucker
 - ◆ A handout was provided on fall SSCH actual compared to budget.
 - ◆ As of this morning, 230 students have not finalized their registration.
 - ◆ The 11th class day has been moved to January 24 due to the campus closure.
 - ◆ Applications continue to be received and offices are working to get students enrolled.
3. Financials/Outstanding Student Bills – Ms. Halley
 - ◆ Students on hold are being contacted to find options for lowering their bills.
4. Housing Update and Policy Revision Status – Mr. Hughes
 - ◆ There are currently 401 students in residential housing, compared to 365 at this time last year. Students who have not finalized will continue to be contacted.
 - ◆ The approved revisions to the housing policy have been updated for fall 2025. The revisions are also being updated in the student handbook.
5. SGA/Student Activities and Engagement – Mr. Hughes
 - ◆ A list of events and activities that students have an opportunity to engage in was provided and discussed.
6. Commencement, Honor Students from Units/Majors – Ms. Halley and Mr. Hughes
 - ◆ Ways to recognize academic achievements were discussed. Some units have individual recognition ceremonies. This topic will be explored with Academic Council.
7. Voluntary Retirement – Ms. Halley
 - ◆ Information was provided on three requests for voluntary retirement. The Executive Council reviewed and approved all requests.
